SEND UP EXAMINATION 2019

All the students of LL.B. Part-I, II, III (Morning) LL.B. Part-I, II (Afternoon) LL.B. Part-II (Evening) are hereby informed that the **“Send up Examination”** will be conducted w.e.f. **18-03-2019**.

Following rules will be observed in the send up Examination 2019.

1. Only those students will be allowed to appear in Send up Examination 2019, who have paid all college/University dues. Dues will not be accepted after Send up Examination.
2. Only those students will be considered pass who will obtain 45% marks in at least 4 papers.
3. Fine will be imposed to full fail/absent students.
4. The concession of 10% lectures will only be given to those students who will pass the send up examination.
5. The admission forms for Annual Examination will be received from those students who will appear and pass the send up examination obtaining 45% marks.

All the students are advised in their best interest to appear in the send up examination.
