They are directed to appear personally before the Principal on **17-11-2017 at 11:00A.M** (Sharp), along with all original educational documents, CNIC and fee. They will be considered for admission in order of Merit on the date and time mentioned above.

1. Students shall pay their dues in the University Branch of Habib Bank Limited (Quaid-e-Azam Campus) after obtaining necessary Challan form from the Law College Office.
2. The Bank Challan forms shall be issued by the office on **17-11-2017**. The College dues in any case shall have to be deposited before the close of Banking hours on **17-11-2017**. Those who do not deposit their dues within the prescribed time shall lose their right to admission.
3. Before getting the Challan form for payment of dues, submit original Matric, F.A./F.Sc./B.A./B.Sc. Degree/Result Card/Equivalence and Migration Certificate in the Evening office. If documents are submitted in any other department, then proof must be shown at the time of Physical appearance.
4. Any Candidate who is found (at any time) to have obtained admission by making any mis-statement in the admission form or by willful concealment of any material fact (Particularly about Marks, Division, previous admission to the University Law College etc.) shall be expelled without notice from the Law College, Lahore.
5. The College reserves the right to correct any typographical errors, omission, etc.
6. It is directed that, the applicants who will present at the time of physical appearance, they may be given preference for admission in case of any vacant seat in accordance with merit.
