3. The Bank Challan forms shall be issued by the office with effect from **26-11-2020 upto 04-12-2020**. The College dues in any case shall have to be deposited before the close of Banking Hours on 04-12-2020. Those who do not deposit their dues within the prescribed time shall lose their right to admission.
4. Before getting the Challan form for payment of dues, submit original Matric, F.A./F.Sc. Degree / Result Card, Migration Certificate, LAT Result Card and three passport size pictures to **Mr. Malik Mumtaz Ahmad, Assistant Officer in (Room No. 06)**. The College reserves the right to correct any typographical errors, omission, etc.
5. Those candidates who have got 20 extra marks of Hafiz-e-Quran claim and their name appeared in the merit list, they are required to qualify the Verbal Test of Holy Quran before issuance of the Challan Form.
6. The total annual Dues for the academic session 2020-2021 is Rs.31000/- and submit hard copy of online form/original challan form of Rs.500/- herewith.
