3. The Bank Challan forms shall be issued by the office from **07-02-2022 upto 10-02-2022**. The College dues in any case shall have to be deposited before the close of Banking Hours on 10-02-2022. Those who do not deposit their dues within the prescribed time shall lose their right to admission.
4. Before getting the Challan form for payment of dues, submit original Matric, F.A./F.Sc. Degree / Result Card, Migration Certificate, LAT Result Card and three passport size picture and Rs.100 Stamp Paper to **Mr. Malik Mumtaz Ahmad, Assistant (Room No. 06)**. The College reserves the right to correct any typographical errors, omission, etc.
5. Those candidates who have got 20 extra marks of Hafiz-e-Quran claim and their name appeared in the merit list, they are required to qualify the Verbal Test of Holy Quran before issuance of the Challan Form.
6. The total Annual Dues for the academic session 2021-2022 is Rs.31135.
7. The Candidate are required to submit hard copy of online form/original challan form of Rs.500/- herewith.
