Degree / Result Card, Migration Certificate, LAT Result Card and three passport size picture and Rs.100 Stamp Paper to **Mr. Malik Mumtaz Ahmad, Assistant (Room No. 06)**. The College reserves the right to correct any typographical errors, omission, etc.
5. Those candidates who have got 20 extra marks of Hafiz-e-Quran claim and their name appeared in the merit list, they are required to qualify the Verbal Test of Holy Quran before issuance of the Challan Form.
