

**ADMISSION NOTICE-III (LL.B. PART-I) EVENING CLASS FOR THE
SESSION 2017-2018.**

The following candidates have been selected for admission to the LL.B. Part-I class of the University Law College, Quaid-e-Azam Campus, Lahore, for the ensuing academic session subject to the following conditions:-

1. Any Candidate who is found (at any time) to have obtained admission by making any mis-statement in the admission form or by willful concealment in any material fact (Particularly about Marks, Division, Previous admission to the University Law College etc.) shall be cancelled with immediate effect from the University Law College, University of the Punjab, Lahore and a criminal proceeding shall be initiated against such student.
2. Students shall pay their dues in the University Branch of Habib Bank Limited (Quaid-e-Azam Campus) after obtaining necessary Challan form from the Law College Office.
3. The Bank Challan forms shall be issued by the office with effect from **13-11-2017** upto **15-11-2017**. The College dues in any case shall have to be deposited before the close of Banking hours on **15-11-2017**. Those who do not deposit their dues within the prescribed time shall lose their right to admission.
4. Before getting the Challan form for payment of dues, submit **original Matric, F.A./F.Sc./B.A./B.Sc. Degree/Result Card/Equivalence and Migration Certificate** in the evening office.
