Pakistan is a signatory to Sustainable Development Goals and is the first country in the world to adopt SDGs as the national development agenda through a National Assembly Resolution for the acceleration of SDGs, Ministry of Planning. Development & Special Initiatives developed the National SDGs Framework and aligned several national policies and plans with SDGs, followed by frameworks for provinces and area governments. Efforts have also been made to mainstream SDGs in development planning and budgeting processes of the government at all levels. In addition to that evidence based policy making, awareness raising, coordination, partnerships and learning alliances on SDGs have also been enhanced. SDGs is an ambitious agenda and the achievement of its targets requires collective efforts of all stakeholders. The role of academia is core to achieve SDGs in the evidence based policy as well as teaching the sustainability curriculum to the students and comply with the spirit of SDGs, i.e. inclusivity, equity and sustainability. 3.
