The applications of the following candidates have been accepted for admission to the 04 Years LL.B Program, of the University Law College, Quaid-e-Azam Campus, Lahore, for the ensuing academic session with the following conditions:-

1. Any Candidate who is found (at any time) to have obtained admission by making any mis-statement in the admission form or by willful concealment in any material fact particularly about Marks, Division, Previous admission to the University Law College etc, his/her admission shall be cancelled with immediate effect and a criminal proceeding shall be initiated against such candidate.
2. The Bank Challan forms shall be issued by the office from **11-09-2025 to 15-09-2025**. The Challan Form shall be deposited within Banking Hours on 15-09-2025. Those who do not deposit their dues within the prescribed time shall not be eligible for admission.
3. Candidates are required to submit original Matric, F.A./F.Sc. Degree / Result Card, Migration Certificate, LAT and P.U Entry Test Result Card FRC, Service Certificate from Registrar Office, three passport size pictures and an affidavit on Rupees 200 E-Stamp Paper duly Attested by Oath Commissioner to **Malik Mumtaz Ahmad, Administrative Officer (Semester Cell)**.
4. The candidate must provide equivalence/verification of their academic documents from the Inter Board Committee of Chairman (IBCC) at the time of admission.
5. Those candidates who have applied on the basis of Hafiz-e-Quran shall have to qualify the Verbal Test of Holy Quran before issuance of the Challan Form.
6. The Candidate are required to submit hard copy of online form/original challan form of Rs.500/- herewith.
