- 5. The candidate must provide equivalence/verification of their academic documents from the Inter Board Committee of Chairman (IBCC) at the time of admission.
- 6. Those candidates who have applied on the basis of Hafiz-e-Quran shall have to qualify the Verbal Test of Holy Quran before issuance of the Challan Form.
- 7. The Candidate are required to submit hard copy of online form/original challan form of Rs.500/- herewith.
