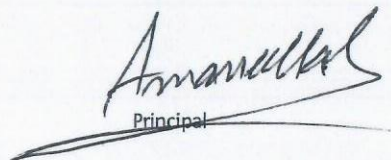

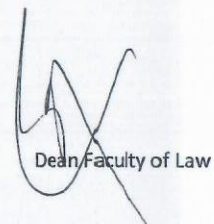
3. The Bank Challan forms shall be issued by the office from **06-10-2025 to 07-10-2025**. The Challan Form shall be deposited within Banking Hours on 07-10-2025. Those who do not deposit their dues within the prescribed time shall not be eligible for admission.
4. Candidates are required to submit original Matric, F.A./F.Sc. Degree / Result Card, Migration Certificate, LAT and P.U Entry Test Result Card, Service certificate from Registrar Lahore High Court, three passport size picture and affidavit on Rupees 200 E-Stamp Paper duly Attested by Oath Commissioner to **Mr. Malik Mumtaz Ahmad, Admin Officer (Room No. 04).**
5. The candidate must provide equivalence/verification of their academic documents from the Inter Board Committee of Chairman (IBCC) at the time of admission.
6. Those candidates who have applied on the basis of Hafiz-e-Quran shall have to qualify the Verbal Test of Holy Quran before issuance of the Challan Form.
7. The Candidate are required to submit hard copy of online form/original challan form of Rs.500/- herewith.
