Degree / Result Card, Migration Certificate, LAT Result Card and three passport size picture and Rs.100 Stamp Paper to **Mr. Malik Mumtaz Ahmad, Assistant (Room No. 06)**. The College reserves the right to correct any typographical errors, omission, etc.
5. The candidate submit Minorities religion Certificate from competent authority.
6. The total Annual Dues for the academic session 2022-2023 is Rs.44565/-
7. The Candidate are required to submit hard copy of online form/original challan form of Rs.500/- herewith.




